Instructions for Authors

The aim of The World Journal of Biological Psychiatry is to increase the worldwide communication of knowledge in clinical and basic research on biological psychiatry. The composition of The World Journal of Biological Psychiatry, with its diverse categories that allow communication of a great variety of information, ensures that it is of interest to a wide range of readers. It offers the opportunity to educate (through critical review papers), to publish original work and observations (original papers), and to express personal opinions (Viewpoints/Letters to the Editor). The World Journal of Biological Psychiatry is thus an extremely important medium in the field of biological psychiatry all over the world.

Manuscripts must be written in standard and grammatical English and should present new results as well as be of scientific value. Contributions will be considered for the following categories:

- Editorials
- Reviews/Mini-reviews
- Original investigations/Summaries of original research
- Brief reports
- Viewpoints
- Letters to the Editor
- Book reviews
- Invitations/Announcements

Beginning January 1 2008, the Journal will no longer accept Case Reports/Case Series for review. Authors are encouraged to submit such findings as Letters to the Editor.

The World Journal of Biological Psychiatry's Manuscript Central, web-based manuscript submission and handling system, is now available. **Please submit all manuscripts online via Journal's manuscript Central site: <http://mc.manuscriptcentral.com/swbp>**

Click on "online submission" which directs you to Manuscript Central's log in page. Here either create an account or enter an existing account to log in your "author centre" to upload manuscripts. If you have difficulties in submitting your manuscript electronically, or if you require additional assistance, contact the World Journal of Biological Psychiatry's Editorial Office at: editorialoffice@wfsbp-journal.org.

The receipt of the manuscript will be acknowledged by an e-mail which includes a manuscript ID number. Each manuscript will be assigned to at least two reviewers. The manuscript ID number should be quoted in all correspondence with the Chief Editor and Editorial Office.

Submit manuscript text as a Word file and Figures as separate TIF or EPS format files. Use Times New Roman 12 point and double spacing throughout the manuscript. Use a clear system of headings to divide up and clarify the text, with not more than three grades of headings. The desired position of figures and tables should be indicated in the manuscript. Submission of a manuscript implies: that the work described has not been published before (except in the form of an abstract or as part of a published lecture, review or thesis); that it is not under consideration for publication anywhere else; that its publication has been approved by all co-authors, if any, as well as by responsible authorities - tacitly or explicitly - at the institute where the work has been carried out.

Manuscripts submitted for publication must contain a statement to the effect that all human studies have been approved by the appropriate ethics committee and have therefore been performed in accordance with the ethical standards laid down in the 1964 Declaration of Helsinki. It should also be stated clearly in the text that all persons gave their informed consent prior to their inclusion in the study. Details that might disclose the identity of the subjects under study should be omitted.

Reports of animal experiments must state that the Principles of laboratory animal care (NIH publication No. 86-23, revised 1985) were followed, as well as specific national laws (e.g., the current version of the German Law on the Protection of Animals) where applicable.

The editors reserve the right to reject manuscripts that do not comply with the above-mentioned requirements. The author will be held responsible for false statements or for failure to fulfil the above-mentioned requirements.

Manuscript specifications

1. The *manuscript text file* shall contain a title page. On the title page the following shall be stated: The title of the article, which should be concise but informative. A short title not exceeding 40 letters and spaces. The full names, affiliations and addresses of all the contributors, and e-mail address, telephone number and fax number for the corresponding author. The title page should also include details of the number of words, figures, and tables.
2. Each article must include a short *Abstract* of the essential results (not exceeding 200 words).
3. *Key words*. Up to five key words should be inserted below the abstract. Use terms from the Medical Subject Headings list from Index Medicus.
4. *Conflict of interest statement* – for further details see note below
5. *References*. All references cited in the text are to be listed (double-spaced) at the end of the paper in alphabetical order under the name of the first author. If there are more than six authors, list the first six authors and use ‘et al.’ Articles ‘in press’ may be included, but must state the journal that has accepted them. Personal communications should be avoided. Journal titles should be abbreviated according to *Index Medicus*.

Citations in the text should be by author and date in parentheses. If there are two authors, both should be named (e.g., Agar and Douglas 1955); if an article with more than two authors is cited, only the first author’s name plus ‘et al.’ need be given (e.g., Komor et al. 1979); if there is more than one reference by the same author or team of authors in the same year, then a, b, c, etc., should be added to the year, both in the text and the list of references. When styling references, the following examples should be followed:

1. Brain WR. 1958. The physiological basis of consciousness. A critical review. *Brain* 81: 426-455.
2. Kuhlenbeck H. 1954. The human diencephalon. A summary of development, structure, function and pathology. Basel: Karger.
3. Teuber HL. 1964. The riddle of frontal lobe function in man. In: Warren T, Akert CH, editors. The frontal and granular cortex and behavior. New York: McGraw-Hill, pp 252-271.

6. *Tables* should be included in the main manuscript file but on separate pages and numbered consecutively with Arabic numbers. All tables should include a brief descriptive caption.
7. *Figures*. All illustrations, whether photographs, graphs or diagrams, should be numbered consecutively with Arabic numerals and submitted as separate files. Each illustration should be referred to in the text as ‘Figure 1’, ‘Figures 1-4’, etc. The figures should have a short title followed by a concise description. All abbreviations and symbols appearing in the figure must be explained in the legend. Remarks such as ‘for explanation (or details) see text’ should be avoided. Each figure should have a legend containing sufficient information to render the figure intelligible

without reference to the text. The figure legends should be included in the manuscript. If a figure has been published previously, acknowledge the original source and submit written permission from the copyright holder to reproduce it. If photographs of persons are used, either the subjects must be unidentifiable or their written permission to use the photographs must accompany the manuscript. Figures can be uploaded as separate files in TIFF format.

Conflict of interest statement

Authors are requested to disclose any commercial or other associations that might pose a conflict of interest in connection with the submitted article. All funding sources supporting the work, and institutional and corporate affiliations of the authors must be acknowledged on the title page of the main manuscript file. Any conflict of interest should be noted with a separate heading, included in the main manuscript file after the main text but before the references. If you do not have any conflict of interest please state that on the title page. All authors are also prompted to confirm this during the submission process in the online system. Manuscripts that do not include this statement may be sent back to the author for completion.

Copyright

It is a condition of publication that authors assign copyright or license the publication rights of the contents of their articles, including abstracts, to Informa Healthcare. This enables full copyright protection and dissemination of the article and the Journal, to the widest possible readership in electronic and print formats. A document to verify this will be sent upon acceptance for publication. This document should be signed by the corresponding author and returned to the publisher for archiving. Proofs and offprints

Authors will be notified via e-mail when a manuscript is ready for final approval before publication. This e-mail provides instructions on how to log on to the online author service, where the final version of the manuscript can be downloaded as a printer ready PDF file.

To avoid delays of publication, proofs should be checked immediately and returned electronically through the online service, following the instructions given. Corrections submitted via the telephone are not accepted. Authors are advised that they are responsible for proof-reading of the text, references, tables and figures for absolute accuracy. Additional material or major corrections cannot be accepted at this stage, nor is substantial rewriting of paragraphs permitted. Such extensive changes may result in a delay or withdrawal of the article from publication. Any costs arising from major additional changes may also be charged to the authors.
